

## WNT accountability for 2020 for the Foundation Amsterdam Institute for Advanced Metropolitan Solutions (AMS)

On 1 January 2013 a law on standard remuneration for top executives in the public and semi-public sectors (WNT) was introduced. This accountability was established based on regulations applicable to the Foundation Amsterdam Institute for Advanced Metropolitan Solutions (AMS): the general WNT maximum. The maximum remuneration in 2020 for the Foundation Amsterdam Institute for Advanced Metropolitan Solutions (AMS) with an employment contract was €201.000 (2019: €194.000).
